Trial Chamber VII ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido* ('Bemba et al. case'), having regard to Article 64(3) of the Rome Statute ('Statute'), Rule 132(1) of the Rules of Procedure and Evidence ('Rules') and Regulation 54 of the Regulations of the Court ('Regulations'), issues the following 'Order setting the agenda for the status conference on 24 April 2015'.

- On 23 February 2015, the Chamber issued an order seeking submissions from the parties on potential agenda items for the first status conference, no later than 20 March 2015.¹
- 2. On 10 March 2015, the Chamber granted a joint request² made by the defence for Mr Bemba, Mr Kilolo, Mr Mangenda Kabongo, Mr Babala Wandu and Mr Arido (together, the 'Defence'), the for extension of the aforesaid deadline until 13 April 2015.³
- 3. On 20 March 2015, the Office of the Prosecutor (the 'Prosecution') and the Registry filed their observations on the agenda of the first status conference.⁴
- 4. On 1 April 2015, the Chamber rejected two further requests⁵ for extension of deadlines submitted by the defence of Mr Arido and the defence of Mr Babala.⁶

- 5. On 8 April 2015, the defence for Mr Babala,⁷ and on 13 April 2015, the rest of the Defence, filed their observations in preparation for the status conference.⁸
- 6. Taking into account these observations, the Chamber hereby issues the final agenda for the status conference:
- a) Timing, volume and modalities of disclosure.
- b) Languages to be used in the proceedings.
- c) Estimated number of: (i) witnesses and any known protection issues, including possible referrals to the Court's witness protection programme and (ii) documentary and other non-testimonial evidence to be relied upon at trial.
- d) Presence of the accused during trial.
- e) Filing of additional auxiliary documents.9
- f) Commencement date of the trial.
