Introduction

- The Office of the Prosecutor ("Prosecution") provides notice of the re-issue of metadata of incriminating evidence, of potentially exculpatory evidence, and of material pursuant to Rule 77 of the Rules of Procedure and Evidence ("Rules"), by way of three disclosure packages:
 - a. Pre-Trial INCRIM Package 38 contains 668 items;
 - b. Pre-Trial PEXO Package 23 contains 66 items; and
 - c. Pre-Trial Rule Package 36 contains 1380 items.

Re-issue of metadata

- 2. The Prosecution notifies the Trial Chamber I ("Chamber") of its re-disclosure, on 16 February 2015, of 668 incriminating items (together with the list of documents re-disclosed), ¹ 66 potentially exculpatory items, ² and 1380 items disclosed pursuant to Rule 77 of the Rules.³ The metadata of these items is being re-disclosed following the Prosecution's request, dated 6 February 2015, to extend the time limit pursuant to regulation 35 of the Regulations of the Court for the re-disclosure of the metadata relating to 2115 documents.⁴ The Prosecution notes that the total number of documents disclosed on 16 February 2015 is 2114, and not 2115, because one document was already re-disclosed on 6 February 2015.⁵
- 3. The re-disclosed material was provided in a format that complies with the e-Court protocol as approved at the Pre-Trial stage.⁶
- 4. 228 items disclosed as incriminating, 18 items disclosed as potentially exculpatory and 312 items disclosed pursuant to Rule 77 of the Rules were re-disclosed with

redactions applied to their metadata, in accordance with decision ICC-02/11-01/11-737 and its Annex ("Redaction Protocol"). The information redacted includes names of investigators and OTP sources. The request to maintain the redactions to names of investigators is also contained in the Prosecution's request dated 6 February 2015.⁷
