**Trial Chamber I** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Laurent Gbagbo*, having regard to Regulations 23 *bis*, 24 and 34 of the Regulations of the Court ('Regulations') issues the following 'Order reducing the time limit to file a response'.

- 1. On 21 October 2014, the Defence team for Mr Laurent Gbagbo ('Defence') filed a 'Requête urgente, fondée sur des circonstances humanitaires exceptionnelles, déposée afin que le Président Gbagbo soit autorisé à se recueillir devant la dépouille de sa mère et à assister à son enterrement' ('Defence Request'),<sup>1</sup> in which it, inter alia, requests Mr Gbagbo's interim release for a period of time not shorter than three days, subject to a number of conditions and guarantees, in order to participate in his mother's funeral.
- 2. On 22 October 2014, the Defence filed a public redacted version of the Defence Request.<sup>2</sup> Pursuant to Regulation 23 *bis* of the Regulations, the Chamber instructed the Registry to urgently reclassify the filing as 'confidential'.<sup>3</sup> The Chamber notes that the Legal Representative of victims was notified of the Defence Request on 22 October 2014.
- 3. According to Regulation 24 of the Regulations, the parties may file a response to any document filed by any participant in the case. Victims or their legal representatives may also file a response when they are permitted to participate in the proceedings in accordance with Article 68(3) of the Statute, and Rule 89(1) of the Rules of procedure and evidence.

- 4. Pursuant to Regulation 34(b) of the Regulations, '[...] unless otherwise ordered', a response shall be filed within 21 days of notification of the document to which the participant is responding.
- 5. In light of the urgency and the nature of the request, the Chamber decides to reduce the time limit to file a response.

## FOR THE FOREGOING REASONS, THE CHAMBER HEREBY

**ORDERS** the Prosecution and the Legal Representative of victims to file a response to the Defence Request, if any, by 24 October 2014; and

**INSTRUCTS** the Registry to file observations on the Defence Request by 24 October 2014.
