


**Trial Chamber I** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Charles Blé Goudé* ('Blé Goudé case'), issues the following 'Decision notifying the election of the Presiding Judge'.

1. On 20 December 2014, the Presidency of the Court referred the *Blé Goudé* case to Trial Chamber I, composed of Judge Cuno Tarfusser, Judge Olga Herrera Carbuccion and Judge Geoffrey Henderson.<sup>1</sup> The record of the proceedings was transmitted to the Chamber on the same day.<sup>2</sup>
2. Pursuant to Regulation 13(2) of the Regulations of the Court, the judges of Trial Chamber I elected a Presiding Judge and **HEREBY DECLARE** that Judge Geoffrey Henderson is the Presiding Judge.
