NOTING the decision of the Presidency of 22 June 2011 constituting Pre-Trial Chambers whereby, *inter alia*, Pre-Trial Chamber III was composed of Judges Odio Benito, Fulford and Fernández de Gurmendi;²

NOTING the decision of the Presidency of 29 April 2009 constituting Pre-Trial Chambers whereby, *inter alia*, Pre-Trial Chamber II was composed of Judges Kaul, Trendafilova and Tarfusser;³

- (v) The Pre-Trial Chambers shall be constituted as follows:

Pre-Trial Chamber I – Libya; CIV

Judge Fernández de Gurmendi

Pre-Trial Chamber II - Uganda; DRC; Darfur; CAR; Kenya
