I. Notification

1. The Office of the Prosecutor ("Prosecution") notifies Trial Chamber VII ("Chamber") of the filing of the "Prosecution's Third Further Request for Disclosure of Evidence in a Related Article 70 Proceeding" ("Request")¹ in the *Bemba* case.
