The Appeals Chamber of the International Criminal Court,

In the appeal of Mr Laurent Gbagbo against the decision of Trial Chamber I entitled “Ninth decision on the review of Mr Laurent Gbagbo’s detention pursuant to Article 60(3) of the Statute” of 8 July 2015 (ICC-02/11-01/15-127-Red),

Noting the “Decision on Prosecution requests to join the cases of *The Prosecutor v. Laurent Gbagbo* and *The Prosecutor v. Charles Blé Goudé* and related matters” of 11 March 2015 (ICC-02/11-01/11-810 and ICC-02/11-02/11-222),

Noting regulations 26 (3) and (4) (d) of the Regulations of the Registry,

Issues the following

ORDER

The Registrar shall by 16h00 on Tuesday, 28 July 2015, re-stamp as “OA 6” and update the metadata of the documents listed in the annex to this order which pertain to the current appeal filed in the *Gbagbo and Blé Goudé* case record as “OA”. The level of classification of these documents shall be maintained until ordered otherwise.


REASONS

1. On 11 March 2015, Trial Chamber I (hereinafter: “Trial Chamber”) joined the case of Mr Laurent Gbagbo (hereinafter: “Mr Gbagbo”) and Mr Charles Blé Goudé (hereinafter: “Mr Blé Goudé”) and ordered the Registrar to open a case record for the joint case and provide access to all parties and participants. Furthermore, the Trial Chamber ordered that all public documents and other material in the respective case records be included in the joint case record of *Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*.

2. The Appeals Chamber observes that with the joinder of the two cases and the transfer of public documents from the respective case records of Mr Gbagbo and Mr Blé Goudé into a joint case record, the documents pertaining to the current appellate proceedings do not bear a consecutive “OA” number.

3. In these circumstances, the Appeals Chamber deems it appropriate to order the Registrar to re-stamp as “OA 6”, by 16h00 on Tuesday, 28 July 2015, documents (listed in Annex A to this order) arising out of the current appeal and which are numbered as “OA” in the joint case record. Furthermore, the Registrar is ordered to update the metadata of these documents.
