TRIAL CHAMBER II of the International Criminal Court, acting in the case of *The Prosecutor v. Germain Katanga*, seized of the "Demande de reclassification présentée par la Ligue pour la Paix, les Droits de l'Homme et la Justice (LIPADHOJ) en vertu des normes 23 bis-3 et 42-3 du Statut" of 27 May 2015,¹ in which LIPADHOJ requested the Chamber, inter alia, to reclassify as "public" documents ICC-01/04-01/07-3533-Conf² and ICC-01/04-01/07-3542-Conf³ as well as its own observations of 15 May 2015 (ICC-01/04-01/07-3552-Conf),⁴ with the exception of paragraph 22 thereof,

Pursuant to regulation 23 bis(3) of the Regulations of the Court,

**ORDERS** the Registry to reclassify documents ICC-01/04-01/07-3533-Conf and ICC-01/04-01/07-3542-Conf as "public"; and

**ORDERS** LIPADHOJ to file a public redacted version of document ICC-01/04-01/07-3552-Conf by 11 June 2015 at 4 p.m.
