
1. On 16 March 2011, the Presidency of the Court constituted Trial Chamber IV and referred to it the *Banda* case.<sup>1</sup>
2. On 17 March 2015, Trial Chamber IV was recomposed with Judge Joyce Aluoch, Judge Chile Eboe-Osuji and Judge Geoffrey Henderson.<sup>2</sup>
3. On 16 October 2015, pursuant to Regulation 13(2) of the Regulations, the judges of the Chamber elected Judge Joyce Aluoch as Presiding Judge.
