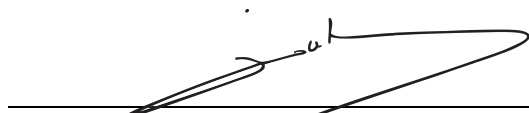
HEREBY INFORMS Trial Chamber VII (the “Chamber”) as follows:

1. On 20 October 2015, the Registrar appointed Mr Lars Göran Hjalmar Hjalmarsson as the legal adviser to witness P-020 pursuant to rule 74 of the Rules;²
2. On the same day, Mr Hjalmarsson was provided with electronic access to the statements and transcripts of interviews of witness P-020, *via* a secure channel in order to maintain at all times due respect for confidentiality;³
3. Mr Hjalmarsson previously discharged the solemn undertakings required by articles 5 and 22(3) of the Code on 11 September 2015.⁴
