Introduction

1. Pursuant to the Trial Chamber's decision of 22 March 2016,¹ the Prosecution submits i) an amended version of its List of Witnesses,² and ii) an amended version of its List of Evidence.³ It also submits a summary of the main facts of Witness P-0626's expected testimony.⁴

List of Witnesses and accompanying Summary of Main Facts

2. Pursuant to the Chamber's Fourth Disclosure Decision,⁵ the Prosecution submits an amended version of its List of Witnesses.⁶
3. Confidential Annex A is a marked-up version of the amended List of Witnesses. The addition of Witness P-0626 appears in mark-up.
4. The Prosecution also submits a summary of the main facts about which Witness P-0626 is expected give evidence, as confidential Annex B.

List of Evidence

5. On 16 February 2016,⁷ 4 March 2016⁸ and 24 March 2016,⁹ the Prosecution disclosed additional incriminating material. Pursuant to the Chamber's Fourth

Disclosure Decision,¹⁰ the Prosecution submits an amended version of its List of Evidence.

6. The Prosecution has also included an additional three items of evidence¹¹ pursuant to the Chamber's previous order of 18 August 2015,¹² which had been inadvertently omitted to date in previous amendments to its List of Evidence.
7. Confidential Annex C is a clean copy of the amended List of Evidence. Confidential Annex D is a marked-up version of the amended List of Evidence, with all additions designated by yellow highlighting. Confidential Annex E is a list of all additions to the List of Evidence.

8. The Prosecution submits Annexes A, B, C, D and E as confidential since they contain the names and identifying information of witnesses and relate to evidentiary material that is currently to be treated as confidential.
