

- 1. On 28 April 2016, 4 May 2016, 19 May 2016, 23 May 2016, 24 May 2016, 25 May 2016² and 1 June 2016,³ the Prosecution disclosed additional incriminating material. The Prosecution now submits an amended version of its List of Evidence. 4 The additions consist of translations of reports already on the List of Evidence, official "best evidence" versions of documents already on the List of Evidence, still images (photographs) derived from material already on the List of Evidence, and transcripts of audio-visual material already on the List of Evidence.
- 2. Confidential Annex A is a clean copy of the amended List of Evidence. Confidential Annex B is a marked-up version of the amended List of Evidence, with all additions designated by yellow highlighting. Confidential Annex C is a list of all additions to the List of Evidence.
