On 21 March 2016, the Chamber issued its Judgment pursuant to Article 74 of the Rome Statute ("Statute"), convicting Mr Jean-Pierre Bemba Gombo under Article 28(a) of the Statute of the crimes against humanity of murder and rape, and the war crimes of murder, rape, and pillaging. The Decision on Sentence pursuant to article 76 of the Statute was issued on 21 June 2016.
- 2. On 6 July 2016, having excused Judge Sylvia Steiner and Judge Kuniko Ozaki from Trial Chamber III, the Presidency decided that the Chamber shall be composed as follows:³
 - Judge Joyce Aluoch
 - Judge Geoffrey Henderson
 - Judge Chang-ho Chung
- 3. On 8 July 2016, the judges of Trial Chamber III elected a Presiding Judge in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* pursuant to Regulation 13(2) of the Regulations of the Court and **HEREBY DECLARE** that Judge Joyce Aluoch is Presiding Judge in the case.
