Jean-Jacques Mangenda hereby requests the reclassification as public of his submissions ICC-01/05-01/13-1930-Conf and ICC-01/05-01/13-1934-Conf.¹ A public redacted version of a third filing, ICC-01/05-01/13-1908-Conf-Corr,² has already been filed.
