**Judge Bertram Schmitt**, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen* having regard to Article 60(3) of the Rome Statute ('Statute') and Rule 118(2) of the Rules of Procedure and Evidence ('Rules'), issues the following 'Order Requesting Observations on Dominic Ongwen's Detention'.

- 1. On 27 November 2015, the Single Judge of the Pre-Trial Chamber ('PTC Single Judge') issued the 'Decision on the "Defence Request for the Interim Release of Dominic Ongwen"' ('Interim Release Decision'),<sup>1</sup> rejecting the Defence request that Mr Ongwen be released, and specifying the reasons why his detention was warranted, pursuant to Article 58(1)(b)(i) and (ii) of the Statute.<sup>2</sup>
- 2. Subsequently, on 23 March 2016, the PTC Single Judge issued the first decision reviewing Mr Ongwen's detention, deciding that Mr Ongwen must remain in detention.<sup>3</sup>
- 3. On 21 July 2016, the Chamber issued the second decision reviewing Mr Ongwen's detention, finding that there had not been any change in the circumstances requiring modification of the Interim Release Decision.<sup>4</sup>
- 4. Pursuant to the statutory framework, Mr Ongwen's pre-trial detention shall be reviewed at least every 120 days. The participants shall be given an opportunity to make any observation on his continued detention or release, with or without conditions, including the existence of any changed circumstances.

- 5. Thus, the Single Judge instructs the defence for Dominic Ongwen ('Defence') to submit its observations, if any, on Mr Ongwen's continued detention or release with or without conditions, including the existence of any changed circumstances pursuant to Article 60(3) of the Statute, by 7 October 2016. The Office of the Prosecutor ('Prosecution') and the Legal Representatives of Victims ('Legal Representatives') are to file any observations on Mr Ongwen's continued detention or release, with or without conditions, including the existence of any changed circumstances, by 21 October 2016. Finally, the Defence is to file its response to these observations, if any, by 28 October 2016.
- 6. Regarding Regulation 51 of the Regulations of the Court, the Single Judge does not anticipate requiring further observations from States beyond those recently received<sup>5</sup> unless justified by a participant's submissions.

## FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

- 7. **ORDERS** the Defence to submit any observations on Mr Ongwen's detention by 7 October 2016;
- 8. **ORDERS** the Prosecution and the Legal Representatives to submit any observations on Mr Ongwen's detention by 21 October 2016; and
- 9. **ORDERS** the Defence to submit any response to the Prosecution and Legal Representatives' observations on Mr Ongwen's detention by 28 October 2016.
