Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber VII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido,* having regard to Article 76 of the Rome Statute ('Statute') and Rule 143 of the Rules of Procedure and Evidence, issues the following 'Sentencing Calendar'.

- 1. On 19 October 2016, the Chamber convicted the five accused of offences against the administration of justice.¹
- 2. In order to facilitate the fair and expeditious conduct of the sentencing in this case, and without prejudice to receiving further submissions or convening status conferences if necessary, the following calendar is set:²
 - (i) The parties are to provide the identities of any witnesses they seek to call for sentencing, along with estimated examination lengths and anticipated testimony summaries. This is to be done by way of a formal filing due 4 November 2016.³ This deadline only applies to witnesses the parties seek to call during the sentencing portion of the proceedings all evidence before the Chamber for purposes of its judgment remains before the Chamber for sentencing.⁴ The parties are also reminded that the Chamber may intervene in the selection and presentation of their evidence in order to ensure the fair and expeditious conduct of the trial.⁵

(ii) Aside from witnesses, the parties must both disclose and formally submit any additional evidence to be considered for sentencing by 23 November 2016.

(iii) The parties may make written submissions on the additional evidence presented and appropriate sentences to be imposed by 7 December 2016. As the Prosecution must make sentencing submissions in relation to all five convicted persons, it may have 80 pages for its written submission. Each defence team will receive 40 pages for purposes of its written sentencing submissions. By this same deadline, the Registry must file a report informing the Chamber of the solvency of each of the convicted persons.

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

DIRECTS that the sentencing in this case will be conducted in accordance with the calendar above.
