#### Introduction

1. The Office of the Prosecutor ("Prosecution") provides notice of the disclosure of incriminating evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute ("Statute"), material falling within the scope of rule 77 of the Rules of Procedure and Evidence ("Rules") and disclosure of materials that are in none of these categories.<sup>1</sup>

### Disclosure of evidence

- 2. On 28 and 30 November 2016 and on 2 and 7 December 2016, the Prosecution disclosed a total of 134 items, including 90 items as incriminating evidence, 37 items under the provision of rule 77, and 7 items that did not fall under these disclosure categories.
- 3. The Prosecution re-disclosed, having lifted certain redactions, (1) the statement of Witness P-0868;<sup>2</sup> (2) two sketches, three letters, two lists and thirteen transcripts of interview, all related to Witness P-0016; (3) an investigation note related to Witness P-0120; (4) six documents related to Witness P-0031; (5) two documents related to Witness P-0012; (6) a statement and a report related to Witness P-0115; (7) the statement of Witness P-0025; (8) a document related to Witness P-0012; (9) the statement of Witness P-0051; (10) a statement and three documents related to Witness P-0110; (11) and the victim application of witness P-0010.
- 4. The Prosecution disclosed as incriminating evidence: (1) one investigation note related to Witness P-0868; (2) five articles related to Witness P-0453; (3) three witness preparation session log and disclosure notes of Witnesses P-0012,<sup>3</sup> P-

0300<sup>4</sup> and P-0883;<sup>5</sup> (4) twelve school records that were recently collected;<sup>6</sup> (5) two transcripts of testimony of Witness P-0932; (6) an investigation note related to Witness P-0868; (7) one statement related to Witness P-0768; (8) three photographs of individuals; (9) a hand drawn map related to Witness P-0300;<sup>7</sup> (10) a report with 2 appendix and a curriculum vitae, all related to Witness P-0810;<sup>8</sup> (11) twenty rule 68(2)(b)(iii) related materials for Witnesses P-0932, P-0551, P-0057, P-0773 and P-0020; (12) three articles related to Witness P-0453;<sup>9</sup> (13) and the addendum to the expert report of Witness P-0810.<sup>10</sup> For technical reasons, the Prosecution could not formally include 2 satellite images related to the expert report of P-0810, which are in a format not supported by Ringtail and e-Court. These items were provided to the Defence on a DVD.

5. The Prosecution disclosed, under rule 77: (1) a letter related to Witness P-0012; (2) the schedule of contact between P-0154 and intermediaries and witnesses;<sup>11</sup> two witness preparation session logs and disclosure notes of Witnesses P-0898<sup>12</sup> and P-0002;<sup>13</sup> (3) the identity card of Witness P-0868;<sup>14</sup> (4) a report<sup>15</sup> and an investigation note related to P-0154;<sup>16</sup> (5) ten photographs and a note; (6) five sketches related to Witness P-0867;<sup>17</sup> (7) and the witness preparation session log and disclosure note of Witness P-0121 as well as the notes the witness took during the preparation sessions.<sup>18</sup>

- 6. Lastly, the Prosecution disclosed as a courtesy (1) the witness preparation session log and disclosure note of Witness P-0761;<sup>19</sup> (2) and four draft transcripts and two draft translations of transcripts of videos.
- 7. Consistent with its standard practice, the Prosecution transmitted these items to the Registry for uploading into e-Court, which gives the Chamber, Parties and participants access to the materials.
- 8. The Prosecution appends the list of the evidence disclosed in Confidential Annex A.
