Introduction

- The Prosecution hereby provides its monthly report relating to disclosures to Mr Gbagbo and Mr Blé Goudé, on 9 February 2017, 13 February 2017 and 15 February 2017.
- 2. All disclosed material was provided *via* TRIM electronically, in a format that complies with the e-Court Protocol as approved for the trial stage.¹

3. Annexes A,² B,³ C,⁴ D,⁵ E⁶ and F⁷ appended to this communication contain the disclosure letters and lists provided to the Accused. The Prosecution requests that these annexes be received as "Confidential" since they relate to *inter partes* disclosure.

Disclosure of 9 February 2017

- 4. The Prosecution provides notice of the disclosure, on 9 February 2017, to Mr Gbagbo and Mr Blé Goudé, of Metadata Update package,8 containing three items, already disclosed as incriminating evidence and on the List of Evidence. The "Confidentiality" level metadata field was updated.

Disclosure of 13 February 2017

- 6. The Prosecution provides notice of the disclosure, on 13 February 2017, to Mr Gbagbo and Mr Blé Goudé, of Rule 77 package 59° containing nine items. Two items were disclosed in unredacted form and two items contained redactions to their content only, in accordance with decision ICC-02/11-01/11-737 ("Redaction Protocol"). The package consisted of:
 - a. An investigator's report, dated 10 February 2017, related to copies of police documents collected from Witness P-0046 during his interview in November 2011.¹¹ The document was disclosed ahead of this witness's testimony;
 - b. An investigator's report, dated 22 September 2012, related to leads provided by Witness P-0109;¹²
 - c. An investigator's report, dated 8 February 2017, related to Witness P-0402's security concerns;¹³
 - d. A press article related to the trial of Mr Gbagbo and Mr Blé Goudé before the International Criminal Court.¹⁴ The Prosecution became aware of the existence of this document while running searches. The Prosecution disclosed this document as part of its ongoing review of material relating to its case;
 - e. Five psycho-social assessment reports of Witnesses P-0458, P-0436, P-0438, P-0433 and P-0458.¹⁵ The Prosecution disclosed these documents in conformity with the Chamber's oral decision of 1 July 2016.¹⁶

Disclosure of 15 February 2017

- 8. The Prosecution provides notice of the disclosure, on 15 February 2017, to Mr Gbagbo and Mr Blé Goudé, of INCRIM package 59,¹⁷containing 13 items disclosed in unredacted form. The package consisted of:
 - a. One transcript¹⁸ related to an RTI video¹⁹ previously disclosed as incriminatory evidence and included in the List of Evidence;
 - b. Six transcripts²⁰ related to a video²¹ previously disclosed as incriminatory evidence and included in the List of Evidence;
 - c. Six transcripts²² related to RTI videos²³ previously disclosed as incriminatory evidence and included in the List of Evidence. These transcripts were sent to the Defence via courtesy copy on 13 February 2017 in advance of Witness P-0046's testimony.
