# I. Introduction

 This report is being filed further to the Chamber's "Order pursuant to rule 103 of the Rules of Procedure and Evidence" ("the Order") of 15 July 2016 inviting the States concerned as well as any interested organizations to submit their observations by 30 September 2016 (paragraph 8 of the Order).<sup>1</sup>

## II. Classification

2. Annexes 1-7 and 9-14 to this report are classified in accordance with regulation 23 *bis*(1) of the Regulations of the Court as confidential *ex parte*, available only to the participants and NGOs submitting observations, because they contain the names and contact details of staff members of those organizations and have not yet been reviewed by the Chamber. At the request of the authorities of the Democratic Republic of the Congo (DRC), annex 8 is classified as confidential, available only to the participants. Annex 15, containing the observations of the United Nations, is classified as public at the UN's request.

## III. Legal basis

3. This report is being filed on the basis of rules 13(1) and 103(1) of the Rules of Procedure and Evidence.

## IV. Submissions

- 4. In accordance with the Chamber's Order, the Registry sought the cooperation of the DRC and the assistance of intergovernmental organizations to ensure that the Chamber's invitation was publicized as widely as possible.
- On 26 September 2016, the Registry received the observations of the *Fédération des Jeunes pour la Paix Mondiale* ("FJPM"), along with a proposal for a collective project, dated 25 September 2016. These are appended in annex 1.

The Registry also received observations, as well as a proposal for a collective reparations project, from *Actions Féminines pour la Défense des Droits de l'Homme* ("AFDDHO"), dated 26 September 2016. These are appended in annex 5.
- 8. On 29 September 2016, the Registry received the observations of the Bunia chapter of LIPADHO, dated 29 September 2016, appended in annex 6. It also received the observations of *Terre des Enfants* ("TDE"), dated 29 September 2016. These are appended in annex 7.
- 9. On the same day, via the Registry, the DRC authorities requested an extension of time to submit their observations. The note verbale conveying that request is appended in annex 8.
- 10. On 30 September 2016, at 4.17 a.m., the Registry received observations from a group of experts, entitled "Observations of Dr. Golden, Mr. Higson-Smith, Professor Ní Aoláin and Dr. Wühler pursuant to Rule 103 of the Rules of Procedure and Evidence", dated 30 September 2016. These observations are appended in annex 9. On the same day, at 2.21 p.m., the Registry received the observations of Child Soldiers International, dated 30 September 2016. These are appended in annex 10.
