I. Introduction

1. In accordance with rule 13(1) of the Rules of Procedure and Evidence and pursuant to the "Order on Publicity of Case Record" ("Order")¹ of Trial Chamber VIII ("Chamber"), the Registry hereby transmits the public redacted version of one report and the confidential redacted versions of two reports received from the experts on reparations appointed by the Chamber in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi* ("Al Mahdi case").

II. Procedural History

- 2. On 19 January 2017, the Chamber appointed four experts ("Appointed Experts" and "Decision of 19 January 2017")² on areas it had previously identified as relevant for the reparations proceedings in the *Al Mahdi* case,³ and ordered them to submit their reports ("Reports"), separately or jointly, to the Chamber, the parties and the Trust Fund by 24 March 2017.⁴
- 3. On 9 March 2017, following a request from the Appointed Experts,⁵ the Chamber granted an extension of time for the submission of the Reports until 28 April 2017.⁶
- 4. On 28 April 2017, the Registry received the Reports from the Appointed Experts.⁷

- 5. On 1 May 2017, the Registry filed the Reports to the Chamber *ex parte* in original version ("Registry's Transmission").8
- 6. On 3 May 2017, the Registry filed the Reports in confidential redacted version.⁹
- 7. On 11 July 2017, the Chamber ordered the Appointed Experts to file public redacted versions of the Reports, in consultation with the Registry, by 4 August 2017.¹⁰

III. Classification

8. Pursuant to article 68(1) of the Rome Statute, regulation 23bis(1) of the Regulations of the Court and in line with the Order, one report is submitted as a public annex, and two annexes, each one consisting of one report, are classified as confidential, available to the parties, the Trust Fund and the Appointed Experts.

IV. Submission

- 9. Following the issuance of the Order, the Registry held consultations with the Appointed Experts and provided recommendations regarding the extent of redactions to be applied to the public redacted version of the Reports, in view of the prevailing security situation in Mali.
- 10. At the time of filing no agreement has yet been reached between the Registry and two¹¹ of the four Appointed Experts regarding the required level of
