THE PRESIDENCY of the International Criminal Court ("Court") notes the memorandum of 17 August 2017, annexed hereto, from the Prosecutor pursuant to regulation 45 of the Regulations of the Court ("Regulations"), informing that the Prosecutor intends to submit a request to a pre-trial chamber for authorisation to open an investigation into the situation in the Republic of Burundi, under article 15(3) of the Rome Statute. The Prosecutor further informs that the request will be filed under seal and accordingly requests that the decision to assign the situation in the Republic of Burundi to a pre-trial chamber also be issued under seal.

The Presidency recalls regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a pre-trial chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45.

The Presidency notes: (i) the decision of 13 March 2015 assigning judges to divisions whereby, *inter alia*, Judges Cuno Tarfusser, Marc Perrin de Brichambaut, Antoine Kesia-Mbe Mindua, Péter Kovács and Chang-ho Chung were assigned to the Pre-Trial Division in accordance with article 39(1) of the Rome Statute and rule 4*bis*(2) of the Rules of Procedure and Evidence;² (ii) the decision of 16 March 2015, pursuant to regulation 46(1) of the Regulations, constituting Pre-Trial Chambers I and II;³ and (iii) the decision of 15 July 2015 assigning Judge Raul C. Pangalangan to the Pre-Trial Division.⁴

The Presidency also notes the current overall workload of Chambers in the Pre-Trial and Trial Divisions, as well as the individual workload of the judges serving in both Divisions.

The Presidency further notes the respective assignments, qualifications and experience of the judges.⁵
