1. On 18 August 2017, the Appeals Chamber directed the Prosecution to file a public redacted version of its “Consolidated Response to the Appellants’ Documents in Support of Appeal” (ICC-01/05-01/13-2170-Conf).¹
2. On 24 August 2017, the Prosecution filed its “Corrected version of ‘Prosecution’s Consolidated Response to the Appellants’ Documents in Support of Appeal’, 10 July 2017, ICC-01/05-01/13-2170-Conf”, and of the glossary annexed as ICC-01/05-01/13-2170-Conf-AnxA,² with an explanatory note.³
3. Simultaneously to the present request, the Prosecution is filing its public redacted version of the Corrected Consolidated Response. Given that a public version of the main submission will be available, the Prosecution requests the Appeals Chamber to reclassify ICC-01/05-01/13-2170-Conf-AnxA-Corr to public, pursuant to Regulation 23*bis* (3) of the Regulations of the Court.
4. This filing is classified as “Confidential” as it references filings so designated. If the Chamber grants this request, the Prosecution submits that this application should also be classified as “Public”.
