In the appeals of Mr Jean-Pierre Bemba Gombo, Mr Aimé Kilolo Musamba, Mr Jean-Jacques Mangenda Kabongo, Mr Fidèle Babala Wandu, and Mr Narcisse Arido against the decision of Trial Chamber VII entitled "Judgment pursuant to Article 74 of the Statute" of 19 October 2016 (ICC-01/05-01/13-1989-Red),

Having before it the "Prosecution Request for Reclassification" of 25 August 2017 (ICC-01/05-01/13-2209-Conf (A A2 A3 A4 A5)),

Having before it the "Request for Reclassification" of 31 August 2017 (ICC-01/05-01/13-2213 (A A2 A3 A4 A5)),

Pursuant to regulation 23bis (3) of the Regulations of the Court,

Issues the following

ORDER

The Registrar is directed to reclassify as public filings ICC-01/05-01/13-2170-Conf-AnxA-Corr, ICC-01/05-01/13-2182-Conf and ICC-01/05-01/13-2209-Conf.

REASONS

- 1. Regulation 23bis (3) of the Regulations of the Court provides that a Chamber may reclassify a document when the basis for the classification no longer exists.
- 2.
