**Trust Fund for Victims** Mr Pieter de Baan **TRIAL CHAMBER II** ("Chamber") of the International Criminal Court ("Court"), acting pursuant to regulation 37 of the Regulations of the Court ("Regulations"), decides as follows.

1. On 13 July 2017, the Chamber instructed the Legal Representatives of the V01 Group of Victims and the Legal Representatives of the V02 Group of Victims ("Legal Representatives V01 and V02"), the Office of Public Counsel for Victims ("OPCV") and the Defence team for Thomas Lubanga Dyilo ("Defence" and "Mr Lubanga", respectively) to file submissions on the evidence admitted in the present proceedings for the determination of Mr Lubanga's liability for reparations ("Order of 13 July 2017").<sup>1</sup>

2. On 21 July 2017, the Chamber extended to 8 September 2017 the time limit set by the Order of 13 July 2017 for the OPCV and Legal Representatives V01 and V02 to file their submissions, and extended to 29 September 2017 the deadline for the Defence's response to the submissions of the OPCV and the Legal Representatives V01 and V02.<sup>2</sup>

3. On 6 September 2017, the Chamber granted the OPCV's request of 5 September 2017 ("Decision of 6 September 2017").<sup>3</sup>

4. On 7 September 2017, the Legal Representatives V01 filed their submissions in accordance with the Chamber's Order of 13 July 2017 ("Observations of 7 September 2017").<sup>4</sup> The same day, the Legal Representatives V01 filed a request for

the Chamber to retroactively grant an extension of the page limit set by the Decision of 6 September 2017 ("Request").<sup>5</sup>

5. On 8 September 2017, the Legal Representatives V01 filed a new version of their Observations of 7 September, complying with the page limit set by the Decision of 6 September 2017.<sup>6</sup>

## FOR THESE REASONS, the Chamber

**FINDS** the Request to be moot.
