1. On 24 January 2018, the Appeals Chamber directed the Prosecution to file a public redacted version of its “Prosecution’s Consolidated Response to Mr Bemba’s, Mr Babala’s, and Mr Arido’s Appeals against the Sentencing Decision” (ICC-01/05-01/13-2203-Conf).¹
