I. Introduction


1. The Registry hereby transmits to Trial Chamber I (“Chamber”) one document from Mr Gbagbo and one document from Mr Blé Goudé, both dated 16 January 2019, and received by the Registry on that same date, pursuant to the Oral Decision on the Prosecutor’s request under article 81(3)(c)(i) of the Statute.¹

II. Applicable Law

2. The present submission is made pursuant to rule 13(1) of the Rules of Procedure and Evidence and regulation 24*bis* of the Regulations of the Court.

III. Submission

3. During the hearing held on 16 January 2019, Trial Chamber I directed
 “the Registry to obtain the necessary assurances from Mr Gbagbo and Mr Blé Goudé and their respective lead counsel in ensuring the return of Mr Gbagbo and/or Mr Blé Goudé, if and when their presence at the seat of the Court is requested [...]” (“Requested documents”).²
4. After the hearing, Mr Gbagbo and Mr Blé Goudé signed the Requested documents and handed them over to a representative of the Registry.
5. The Registry hereby transmits the Requested Documents as:
 - Annex 1 – document signed by Mr Gbagbo, and
 - Annex 2 – document signed by Mr Blé Goudé.
