Introduction

 The Office of the Prosecutor ("Prosecution") provides notice of the disclosure of material falling within the scope of rule 77 of the Rules of Procedure and Evidence ("Rules").

Disclosure of evidence

- On 25 June 2019, the Prosecution disclosed one item under the provision of rule 77.
- 3. On 15 February 2019, the Defence requested¹ a lesser redacted version of a UN document.² Following the UN's consent to lift certain redactions to the document, the Prosecution disclosed one item reflecting the lifted redactions under rule 77.
- 4. The Prosecution notes that the material disclosed to the Defence is subject to protective measures imposed by another Chamber of this Court. It hereby informs the Trial Chamber VI and the Defence of the nature of these protective measures (Confidential Annex B).
- 5. Consistent with its standard practice, the Prosecution transmitted this item to the Registry for uploading into e-Court, which gives the Chamber, Parties and participants access to the material.
- 6. The Prosecution appends the list of the evidence disclosed in Confidential Annex A.
