THE PRESIDENCY of the International Criminal Court ('Court');

NOTING article 61(11) of the Statute, pursuant to which the Presidency shall constitute a Trial Chamber once the charges have been confirmed, which shall be responsible for the conduct of subsequent proceedings; and rule 130 of the Rules of Procedure and Evidence ("Rules") whereby it shall refer the case to a Trial Chamber and transmit to it the Decision Confirming the Charges and the record of the proceedings of the Pre-Trial Chamber;

NOTING the decision of Pre-Trial Chamber I dated 30 September 2019 which, *inter alia*, confirmed, pursuant to article 61(7)(a) of the Statute, certain of the charges presented by the Prosecutor against Mr Al Hassan, to the extent specified at pages 451 to 467 of that decision, and committed him for trial on the charges as confirmed ('Decision Confirming the Charges');<sup>1</sup>

NOTING the decision of Pre-Trial Chamber I dated 18 November 2019 rejecting the request for leave to appeal the Decision Confirming the Charges in the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud*, thereby concluding the proceedings in the case before that Chamber, and ordering the Registrar to transmit the Decision Confirming the Charges and the record of the proceedings to the Presidency;<sup>2</sup>

NOTING that the record of the proceedings before Pre-Trial Chamber I and the Decision Confirming the Charges were transmitted to the Presidency by the Registrar on 20 November 2019, in accordance with rule 129 of the Rules;<sup>3</sup>

NOTING its previous decision assigning judges to divisions and recomposing Chambers;<sup>4</sup>

NOTING further that when composing chambers, the Presidency must balance a number of factors to the extent necessary and possible, and that the guiding principles informing these factors are the applicable statutory framework and the need to ensure the efficient management of the Court's workload, including in view of the Court's long-term needs;

CONSIDERING the current and anticipated overall judicial workload of the Court and the

necessity to ensure sound management of the same, the need to expedite proceedings, the workload and individual concerns of the respective judges, their previous involvement in cases, as well as the experience and expertise of each judge;

**HEREBY DECIDES** to temporarily attach Judge Tomoko Akane, currently assigned to the Pre-Trial Division, to the Trial Division, in accordance with article 39(4) of the Statute;

**CONSTITUTES** Trial Chamber X with immediate effect as follows:



**DECIDES** to refer the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud* to Trial Chamber X;

**ORDERS** the Registrar, pursuant to rule 130 of the Rules, to transmit the full record of the proceedings in the above mentioned case to Trial Chamber X, including the Decision Confirming the Charges; and to notify the present decision to the relevant parties and participants in the case.
