**Pre-Trial Chamber I** (the "Chamber") of the International Criminal Court issues this decision on withdrawal of counsel.

- 1. On 12 May 2017, the Registry informed the Chamber that Karim Khan ("Mr Khan") had been appointed as counsel for Saif Al-Islam Gaddafi ("Mr Gaddafi") and Dato' Shyamala Alagendra ("Ms Alagendra") was appointed as associate counsel in this case.<sup>1</sup>
- 2. On 26 April and 6 July 2018, respectively, the Registry informed the Chamber that Essa Mbye Faal ("Mr Faal") and Aidan Ellis had also been appointed as associate counsel for Mr Gaddafi in this case.<sup>2</sup>
- 3. On 16 July 2018, the Chamber granted the request of Mr Khan to withdraw from the representation of Mr Gaddafi.<sup>3</sup> On 30 July 2018, the Registry informed the Chamber that Ms Alagendra had been appointed counsel for Mr Gaddafi.<sup>4</sup>
- 4. On 6 December 2019, the Chamber received the "Request Pursuant to Regulation 78(1) of the Regulations of the Court", in which Ms Alagendra seeks the Chamber's leave to formally withdraw from her representation as lead counsel for Mr Gaddafi (the "Request"). Ms Alagendra submits that following consultations with Mr Gaddafi, and by mutual agreement, it was agreed that associate counsel Mr Faal would act as effective lead counsel since 1 August 2018, pending his formal appointment as lead counsel. Ms Alagendra further submits that the formal appointment of Mr Fall was delayed [REDACTED]. Finally, Ms Alagendra submits that this planned change in the composition of Mr Gaddafi's legal team will ensure continuity in the latter's legal representation before the Court and will not cause any delays in the Appeals Chamber's determination on Mr Gaddafi's appeal of the Pre-Trial Chamber's

"Decision on the 'Admissibility Challenge by Dr. Saif Al-Islam Gadafi pursuant to Articles 17(1)(c), 19 and 20(3) of the Rome Statute".8

- 5. The Chamber notes article 67(1)(d) of the Rome Statute (the "Statute"), regulations 67 and 78 of the Regulations of the Court (the "Regulations"), regulation 123 of the Regulations of the Registry, and articles 8, 15(2), 17(2), 18(3) and 19 of the Code of Professional Conduct for counsel (the "Code of Conduct").
- 6. The Chamber, noting counsel's wish to withdraw and the fact that this decision was taken by mutual agreement with Mr Gaddafi, hereby grants the Request. However, the Chamber reminds counsel that she remains subject to articles 8, 15 and 17 to 19 of the Code of Conduct. Furthermore, having regard to article 67(1)(d) of the Statute, the withdrawal of Ms Alagendra shall only take effect once the appointment of the new lead counsel for Mr Gaddafi has been formally acknowledged by the Registrar pursuant to regulation 123 of the Regulations of the Registry.
- 7. Finally, the Chamber notes that the Request was filed "confidential *ex parte*, available to the Defence, Prosecution and Registry only". The Chamber, however, sees no reason to derogate from the principle of publicity in this case, and therefore directs the Defence to file a public redacted version of the Request by Thursday 19 December.
