**PRE-TRIAL CHAMBER II** of the International Criminal Court issues this Order placing on the record the email decision of 24 September 2019.

1. On 24 September 2019, during the confirmation of charges hearing, the Chamber rendered a decision on the conduct of proceedings regarding requests for redactions to the live feed of the hearing. The decision was rendered by email sent to the parties and participants (the ‘email decision of 24 September 2019’).
2. On 27 September 2019, the Chamber received the ‘Yekatom Defence Request for Public Redacted Versions of Decisions’, whereby the Yekatom Defence requested, *inter alia*, that the email decision of 24 September 2019 be made part of the public record (the ‘Request’).<sup>1</sup>
3. With a view to ensuring the publicity of the proceedings and the completeness of the case record, the Chamber hereby grants the Request and places its email decision of 24 September 2019 on the record of the case, as an annex to the present order.
