Judge Kimberly Prost, acting as Single Judge of Trial Chamber X of the International Criminal Court, in the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud*, having regard to Article 64(3) of the Rome Statute (the 'Statute') and Rule 132(2) of the Rules of Procedure and Evidence (the 'Rules'), issues this 'Order setting the agenda for the second status conference.'

- 1. On 22 January 2020, the Single Judge rendered a 'Decision on Prosecution request for a variation of time limits relating to the disclosure of evidence and scheduling a second status conference' and scheduled a status conference for 18 February 2020. The Single Judge also invited the parties and participants to submit any proposal for agenda items via email by 11 February 2020.
- 2. In light of the proposals from the parties and participants,³ the Single Judge issues the following agenda for the status conference:
 - A. Update on the Prosecution request to amend the charges.
 - B. Status of *ex parte* filings on the pre-trial record.
 - C. The ongoing *Al Mahdi* reparations proceedings.
 - D. Logistical issues related to Defence investigations.
 - E. Update on Confidentiality Protocol and related issue of contacts with witnesses and/or victims.
 - F. Clarifications related to the Prosecution's provisional list of witnesses.
 - G. Prosecution disclosure obligations, related issues and updates. 4
 - H. Defence notice, if any, under Rules 79 and 80 of the Rules.
 - I. Update on agreed facts under Rule 69 of the Rules.
 - J. E-Court protocol.

K. Other pending matters.

the Single Judge will hold the conference according to the following schedule:

• 9:30 - 11:00 - public session,

• 11:30 – 13:00 – public session.

4. Concerning the last item proposed by the Prosecution, relating to a prospective

request for variation of the time limit for the filing of the pre-trial brief, the

Single Judge directs the Prosecution to make any such request by way of a

written filing.

5. Finally, the Single Judge strongly encourages the parties and participants to

discuss any of the above issues ahead of the status conference on an inter partes

basis.
