No: ICC-01/20 2/3 21 February 2020 **PRE-TRIAL CHAMBER III** ('Chamber') of the International Criminal Court issues this decision concerning the election of the Presiding Judge of the Chamber.

- 1. On 28 September 2018, the Presidency assigned the situation in the Bolivarian Republic of Venezuela to Pre-Trial Chamber I.¹
- 2. On 17 February 2020, the Prosecutor informed the Presidency, in accordance with Regulation 45 of the Regulations of the Court that the Government of the Bolivarian Republic of Venezuela had made a referral pursuant to Article 14 of the Rome Statute concerning a second situation in the Bolivarian Republic of Venezuela ('Situation in the Bolivarian Republic of Venezuela II').
- 3. On 19 February 2020, the Presidency reassigned the first situation and assigned the second situation to the Chamber.²
- 4. On 20 February 2020, pursuant to Regulation 13(2) of the Regulations of the Court, the Judges of the Chamber elected Judge Robert Fremr to serve as the Presiding Judge in the Situation in the Bolivarian Republic of Venezuela II.
