THE PRESIDENCY of the International Criminal Court (the ‘Court’) notes its decision of 8 October 2015, assigning the situation in Georgia to Pre-Trial Chamber I;¹

NOTING regulation 46(1) of the Regulations of the Court, providing that the ‘Presidency shall constitute permanent Pre-Trial Chambers with fixed compositions’;


NOTING that on 25 June 2019 the Presidency constituted Pre-Trial Chamber III;²

NOTING the ‘Decision assigning judges to divisions and recomposing Chambers’ issued on 16 March 2018,³ including the current workload of Chambers in the Pre-Trial Divisions, and the individual workload of the judges, and the Presidency’s overall responsibility for the proper administration of the Court pursuant to article 38 of the Rome Statute, the Presidency hereby decides that the situation in Georgia shall be re-assigned to Pre-Trial Chamber III with immediate effect;

NOTING that the composition of the Pre-Trial Chambers will remain unchanged;

The Presidency hereby directs the Registrar to file and notify this decision to all relevant parties and participants in the situation.
