I. Introduction

1. The Registry submits the present report and its annexes consisting of documents which have been transferred, registered and re-stamped in the case of *The Prosecutor v. Ali Muhammad Ali Abd-Al-Rahman*, pursuant to the “Decision severing the case against Mr Ali Kushayb” (“Decision”), issued on 12 June 2020 by Pre-Trial Chamber II (“Chamber”).¹
2. In the Decision, the Chamber directed the Registry to:
 - open a new case record and assign it a new case number in accordance with regulation 27(1) of the Regulations of the Registry (“RoR”);²
 - transfer all documents relevant to Mr Kushayb to the Chamber, pursuant to regulation 22 of the RoR;³
 - ensure that the newly established case record contain all documents relevant to Mr Kushayb in all available versions, including translations, with the same level of confidentiality.⁴

II. Classification

3. Pursuant to regulation 23*bis*(1) of the Regulations of the Court, Annex II, III and IV to the present submission are classified as “confidential”, “under seal” and “secret” respectively, because they contain information of a confidential nature.

III. Applicable Law


4. For the purpose of the present submission, the Registry has considered *inter alia* article 64(5) of the Rome Statute, rule 136 of the Rules of Procedure and Evidence and regulations 22 and 27 of the RoR.

IV. Submission

5. The Registry hereby informs the Chamber that, in compliance with the Decision, it has opened the new case record of the *Prosecutor v. Ali Muhammad Ali Abd-Al-Rahman*, and assigned it the following case record number ICC-02/05-01/20.
6. Relevant documents in the case of *the Prosecutor v. Ahmad Muhammad Harun* ("Ahmad Harun") and *Ali Muhammad Ali Abd-Al-Rahman* ("Ali Kushayb") listed by the Chamber have been transferred, registered and re-stamped in the record of the case of *The Prosecutor v. Ali Muhammad Ali Abd-Al-Rahman* as at 16 July 2020, in accordance with the Decision.
7. Furthermore, the Registry has maintained the level of classification and identical access of all documents.
