Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge') of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Articles 64(2) and 74(5) of the Rome Statute, issues the following 'Decision on the Postponement of the Delivery Date of the Judgment'.

- 1. On 12 November 2020, the Single Judge scheduled the delivery of the judgment (the 'Delivery Date') for 12 January 2021.¹
- 2. The Single Judge, taking into consideration the arguments brought to his attention by the Defence and the Legal Representatives of Victims in their respective requests² to reschedule this date and, in addition, considering that these requests are unopposed by the Office of the Prosecutor and the Common Legal Representative of Victims,³ hereby reschedules the delivery of the decision under Article 74 of the Statute for 4 February 2021.
- 3. Concerning the request to order a video-link connection for members for the Defence team,⁴ the Single Judge instructs the Defence to liaise with the Registry on this matter. The Single Judge does not object to members from the parties and participants attending remotely and encourages the Registry to facilitate a secure video-link connection.
