**PRE-TRIAL CHAMBER II** (the "Chamber") of the International Criminal Court (the "Court") issues this decision concerning the election of the Presiding Judge of the Chamber.

- 1. On 16 March 2018, the Presidency of the Court recomposed the Chamber and assigned the following situations to it: Central African Republic I; Central African Republic II; Republic of Uganda; Darfur, Republic of the Sudan; Republic of Kenya; Republic of Côte d'Ivoire; Islamic Republic of Afghanistan; and Republic of Burundi.<sup>1</sup>
- 2. The Chamber notes regulation 13(2) of the Regulations of the Court pursuant to which the Judges of each Pre-Trial Chamber shall elect from amongst their members a Presiding Judge.
- 3. On 21 March 2018, the Judges of the Chamber decided that Judge Antoine Kesia-Mbe Mindua will act as the Presiding Judge of the Chamber.
