**PRE-TRIAL CHAMBER A (ARTICLE 70)** of the International Criminal Court issues this Order Recalling the Conditions of Mr Gicheru's Interim Release.

#### I. PROCEDURAL HISTORY

- 1. On 10 March 2015, Pre-Trial Chamber II, in its then composition, issued warrants of arrest against Mr Gicheru and Mr Bett for their alleged responsibility for offences against the administration of justice under article 70(1)(c) of the Rome Statute (the 'Statute').
- 2. On 2 November 2020, Mr Gicheru surrendered himself to the authorities of the Kingdom of the Netherlands.<sup>2</sup>
- 3. On 29 January 2021, upon request of Mr Gicheru, the Chamber issued a decision granting his interim release (the 'Interim Release Decision').<sup>3</sup> In the Interim Release Decision, the Chamber set also out the conditions pursuant to Rule 119 of the Rules of Procedure and Evidence under which the suspect would be released (the 'Conditions').<sup>4</sup> This included the interdiction to 'directly or through any other person, make any public statements, social media post, or communicate with the media about the merits of the case'.<sup>5</sup> It also set out the possible consequences of failure to comply with the Conditions.<sup>6</sup>
- 4. The Chamber notes that, after having arrived in Kenya on 1 February 2021,<sup>7</sup> Mr Gicheru gave an interview on 4 February 2021 to a Kenyan newspaper.<sup>8</sup> Therein, he made statements tangent to the current proceedings.

5. The Chamber hereby reminds Mr Gicheru that the Conditions set out in the Interim Release Decision have to be fullfiled by him at all times. The prohibition on making any statement, social media post, or communication with the media covers all actions which – directly or indirectly – discuss the merits of the case.

# FOR THESE REASONS, THE CHAMBER HEREBY

**RECALLS** the Conditions set out in the Interim Release Decision and that they have to be adhered to at all times.
