I. INTRODUCTION

1. The Prosecution submits to the Single Judge Rosario Salvatore Aitala ("Single Judge"), acting for Pre-Trial Chamber II, this notification of the disclosure of evidence pursuant to articles 61(3)(b) of the Rome Statute.

II. CLASSIFICATION

2. This filing is classified as public with confidential Annexes A-C. The Prosecution classifies Annexes A-C as confidential since they relate to *inter partes* disclosure and contain confidential information.

III. SUBMISSIONS

- 3. On 24 February 2021, the Prosecution disclosed to the Defence 263 items (1,230 pages). The disclosed items are in the following packages:
 - Pre-Confirmation INCRIM package 24: contains 84 items (429 pages)
 - Pre-Confirmation INCRIM package 25: contains 42 items (457 pages)
 - Pre-Confirmation Rule 77 package 15: contains 137 items (344 pages)
- 4. The Prosecution informs the Single Judge that in these packages, the disclosed items relate to the witnesses whose identities cannot be disclosed at this stage and for whom the Prosecution has filed or will file applications for the non-disclosure of witness identities. The Prosecution applied redactions to the information that might reveal the witnesses' identities as instructed by the Chamber. The Prosecution used code F for such redactions.
- 5. The standard redactions applied to the disclosed items are minimal and are applied according to the procedure for exceptions to disclosure that was adopted by the Single Judge on 17 August 2020.²

6. The Prosecution will submit an application for the authorisation of the non-disclosure of the identifying information of the concerned witnesses as instructed by the Chamber.³
