JUDGE CHANG-HO CHUNG, acting as Single Judge of Trial Chamber VI (the ‘Chamber’) of the International Criminal Court, in the case of *The Prosecutor v. Bosco Ntaganda* (the ‘Ntaganda case’), having regard to Regulation 23bis of the Regulations of the Court, issues the present Order.

To ensure the publicity of the case record, and pursuant to the Prosecutor’s request,¹ the Single Judge has reviewed two confidential *ex parte* decisions rendered in the present case by Trial Chamber VI in its prior composition and finds it appropriate to issue public redacted versions of the following decisions:

- a. Order taking interim measures in relation to a Defence investigator and related matters, 23 June 2015, ICC-01/04-02/06-667-Conf-Exp; and
- b. Decision on Prosecution request for suspension of investigators and related matters, 12 August 2015, ICC-01/04-02/06-777-Conf-Exp
