**Trial Chamber II** of the International Criminal Court (the ‘Chamber’), in the case of *The Prosecutor v. Bosco Ntaganda*, having regard to Regulation 13(2) of the Regulations of the Court, issues this ‘Decision on the Election of the Presiding Judge’.

1. On 16 March 2021, the Presidency of the Court recomposed the Chamber to be comprised of Judge Péter Kovács, Judge Chang-ho Chung, and Judge María del Socorro Flores Liera. The Presidency also decided to dissolve Trial Chamber VI and to refer the case of *The Prosecutor v. Bosco Ntaganda* to the Chamber.<sup>1</sup>
2. Pursuant to Regulation 13(2) of the Regulations of the Court, the judges of Trial Chamber II, in its new composition, elected a Presiding Judge and **HEREBY DECLARE** that Judge Chang-ho Chung is the Presiding Judge.
