**Trial Chamber II** of the International Criminal Court (the ‘Chamber’), in the case of *The Prosecutor v. Thomas Lubanga Dyilo*, having regard to regulation 13(2) of the Regulations of the Court, issues this ‘Decision on the Election of the Presiding Judge’.

1. On 16 March 2021, the Presidency of the Court recomposed the Chamber to be comprised of Judge Péter Kovács, Judge Chang-ho Chung, and Judge María del Socorro Flores Liera.<sup>1</sup>
