**PRE-TRIAL CHAMBER I** (the 'Chamber') of the International Criminal Court (the 'Court')

issues this Decision on the Election of the Presiding Judge of the Chamber.

1. On 16 March 2021, the Presidency of the Court recomposed the Chamber and assigned

the following situations to it: Democratic Republic of the Congo; Libya; Republic of Mali;

Gabonese Republic; Registered Vessels of Comoros, Greece and Cambodia; Palestine;

People's Republic of Bangladesh and the Republic of the Union of Myanmar; Plurinational

State of Bolivia; Georgia; Bolivarian Republic of Venezuela I and Bolivarian Republic of

Venezuela II.<sup>1</sup>

2. The Chamber notes regulation 13(2) of the Regulations of the Court pursuant to which

the Judges of each Pre-Trial Chamber 'shall elect from amongst their members a Presiding

Judge who shall carry out the functions conferred upon him or her by the Statute, Rules or

otherwise'.

3. On 18 March 2021, the Judges of the Chamber elected Judge Péter Kovács to act as the

Presiding Judge of the Chamber with immediate effect.
