I. INTRODUCTION

1. The Prosecution submits to the Single Judge Rosario Salvatore Aitala ("Single Judge"), acting for Pre-Trial Chamber II, this notification of the disclosure of evidence pursuant to article 61(3)(b) of the Rome Statute.

II. CLASSIFICATION

2. This filing is classified as public with confidential Annex A. The Prosecution classifies Annex A as confidential since they relate to *inter partes* disclosure and contain confidential information.

III. SUBMISSIONS

- 3. On 1 April 2021, the Prosecution disclosed to the Defence eight items (104 pages) in Pre-Confirmation INCRIM package 56. The package contains the Arabic translation of the witness statement of Witness DAR-OTP-P-0878, six transcripts and an investigation report related to Witness DAR-OTP-P-0921.
- 5. The standard redactions applied to the disclosed items are minimal and are applied according to the procedure for exceptions to disclosure that was adopted by the Single Judge on 17 August 2020. ¹
