I. INTRODUCTION

1. The Prosecution submits to the Single Judge Rosario Salvatore Aitala (“Single Judge”), acting for Pre-Trial Chamber II, this notification of the disclosure of evidence pursuant to article 61(3)(b) of the Rome Statute.

II. CLASSIFICATION

2. This filing is classified as public with confidential Annexes A-C. The Prosecution classifies Annexes A-C as confidential since they relate to *inter partes* disclosure and contain confidential information.

III. SUBMISSIONS

3. On 16 April 2021, the Prosecution disclosed to the Defence two packages, Pre-Confirmation INCRIM package 60 and Pre-Confirmation Reclassification to INCRIM package 2. Together these two packages contain 772 items (6344 pages).

4. Pre-Confirmation INCRIM package 60 contains a lesser redacted version of two documents previously disclosed. Pre-Confirmation Reclassification to INCRIM package 2 contains 770 items previously disclosed under Rule 77 classification.

5. On 20 April 2021, the Prosecution provided metadata updates for four items contained in Pre-Confirmation Metadata Update package 10 (45 pages). These items relate to witness DAR-OTP-P-0924.
