Trial Chamber II of the International Criminal Court (the 'Chamber'), in the case of *The Prosecutor v. Bosco Ntaganda* (the '*Ntaganda* case'), having regard to article 75 of the Rome Statute and Regulation 28 of the Regulations of the Court, issues this Order for the submission of observations on the initial draft implementation plan with focus on priority victims (the 'Order').

- 1. On 8 March 2021, Trial Chamber VI, in its former composition, delivered its Reparations Order, *inter alia*, directing the Trust Fund for Victims ('TFV') to submit, by 8 June 2021 at the latest, an initial draft implementation plan focusing exclusively on the options for addressing the most urgent needs of victims that require priority treatment, relying as much as possible on existing mechanisms, identified intermediaries, and partnership already established.²
- 2. On 8 June 2021, the TFV submitted an initial draft implementation plan with focus on priority victims (the 'initial draft implementation plan').³
- 3. In the view of the Chamber, prior to approving the initial draft implementation plan, the parties shall have the opportunity to submit observations to the Chamber regarding those aspects of the plan affecting their interests and rights.⁴ In addition, the Chamber recalls that, in line with its general approach to reparations,⁵ the TFV was instructed to rely on the Registry and the Legal Representatives for Victims ('LRVs'), in order to ensure that the implementation process and consultations with victims comply with all principles on reparations.⁶ In light of the above, the Chamber considers that the Registry shall also have the opportunity to submit observations on the initial draft implementation plan.
- 4. Consequently, the Chamber directs the parties and the Registry to file any observations they may have on the initial draft implementation plan by 23 June 2021.
