In the review by the Court concerning reduction of sentence of Mr Ahmad Al Faqi Al Mahdi pursuant to article 110 of the Statute,

Recalling that, on 27 September 2016, Trial Chamber VIII sentenced Mr Ahmad Al Faqi Al Mahdi to a sentence of nine years imprisonment (ICC-1/12-01/15-171), which Mr Al Mahdi accepted and chose not to appeal,

Noting that Mr Ahmad Al Faqi Al Mahdi will have served two thirds of the sentence imposed on 18 September 2021,

Considering that article 110(3) of the Statute provides in relevant part that '[w]hen the person has served two thirds of the sentence, [...] the Court shall review the sentence to determine whether it should be reduced',

Considering that rule 224(1) of the Rules of the Procedure and Evidence provides that '[f]or the application of article 110, paragraph 3', three judges of the Appeals Chamber are to be appointed by that Chamber for purposes of conducting the review concerning reduction of sentence,
