- 1. On 11 July 2021 the three judges of the Appeals Chamber ("the Panel") deciding on the review by the Court concerning the reduction of sentence of Mr Ahmad Al Faqi Al Mahdi ("Mr Al Mahdi") pursuant to article 110 of the Statute scheduled a hearing between 21 and 22 September 2021.¹ The Panel invited the Registrar, the Prosecutor and the Legal Representatives of Victims among others to attend the hearing and requested them to inform the Panel of any potential difficulties that may affect the date of the scheduled hearing.²
- 2. The Prosecution informs the Panel that the proposed dates present some difficulties. The senior trial lawyer of the *Al Mahdi* case needs to participate in the hearing but he is scheduled to be in the courtroom in the *Al Hassan* case during the suggested dates. The Prosecution respectfully suggests the week of 27 September to 1 October 2021 as possible alternative dates to hold the hearing.
