- 1. The Prosecution informs the Appeals Chamber of developments regarding [REDACTED] in the trial proceedings which may concern Mr Al Hassan's appeal against Trial Chamber X's decision notifying the Parties and participants of a possible change in the legal characterisation under regulation 55(2) of the Regulations of the Court ("Appeal").¹
- 2. By way of background, in his first ground of appeal, Mr Al Hassan argued that the Trial Chamber erred by finding that it could consider the alleged acts of a sexual nature committed against four specific victims/witnesses (P-0574, P-0542, P-0570 and P-0547) under Counts 1-5 (namely, as torture as a crime against humanity and a war crime, other inhumane acts as a crime against humanity, cruel treatment as a war crime and outrages upon personal dignity as a war crime).²
- 3. The Prosecution respectfully informs the Appeals Chamber that it no longer intends to rely on [REDACTED] for its case against Mr Al Hassan, and has recently informed the Trial Chamber, the Defence and the Legal Representatives for the Victims.³ Notwithstanding, the Trial Chamber's approach articulated in its Decision with respect to all four victims/witnesses remains relevant to the Appeal,⁴ and as such, the Prosecution's legal submissions in its response to the Appeal on this ground remain unchanged.⁵ Accordingly, the Prosecution requests the Appeals Chamber to find that the Trial Chamber's overall approach is correct, notwithstanding that it no longer intends to rely on [REDACTED] for its case.
