
The **ARTICLE 85 CHAMBER** ('Chamber') of the International Criminal Court, in the Article 85 proceedings related to the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé*, issues this 'Decision notifying the election of the Presiding Judge'.

1. On 14 September 2021, following a request for compensation filed pursuant to Article 85 of the Rome Statute by Mr Blé Goudé,¹ the Presidency constituted a chamber for Article 85 proceedings in the present case.²
2. The judges of the Chamber, namely Judges Reine Alapini-Gansou, Joanna Korner, and Sergio Gerardo Ugalde Gordínez, have elected Judge Alapini-Gansou as Presiding Judge.


FOR THESE REASONS, THE CHAMBER HEREBY

DECIDES that Judge Alapini-Gansou is elected as the Presiding Judge; and


