## INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication in relation to the disclosure of evidence relevant to the proceedings against Mahamat Said Adel Kani (“SAID”).

### I. CONFIDENTIALITY

2. This communication and its annex are filed confidential pursuant to regulation 23*bis*(1) of the Regulations of the Court as they relate to the Prosecution’s requests of the same designation.<sup>1</sup>

### II. SUBMISSIONS

3. As part of the preparations for the relevant proceedings against SAID, on 2 March 2021, the Prosecution disclosed “Pre-Confirmation INCRIM Package 001” to the Defence and the Chamber.
